

SECTION 001116 - INVITATION TO BID

Sealed Bids will be received at the office of the Clifton Park Water Authority, 661 Clifton Park Center Road, Clifton Park, NY 12065, until 2:00 PM local time on July 8, 2020, and then at said office publicly opened and read aloud for:

**Interconnection with Saratoga County Water Authority
Contract No. 1**

The project is generally described as the installation of piping and a booster pump station to complete an interconnection between the Clifton Park Water Authority distribution system and the Saratoga County Water Authority transmission main. The work includes all labor, materials, and equipment for the installation of a new packaged booster pump station and the construction of necessary piping, site work, and electrical and controls work to complete the interconnection. Work also includes all other ancillary and restoration work required for a complete and operational installation.

The Project shall be completed on or before December 30, 2020 as indicated in the Agreement.

Bids will be received for a single prime contract. Bids will be received on an itemized unit price basis.

Bids should not include sales and compensating use taxes on materials incorporated into the work.

Bids actually received by mail or by hand after the appointed time on the date specified shall be rejected, notwithstanding that such Bid may have been placed in a mail box or other mail receptacle regularly maintained by the United States Postal Service before such time, and ordinarily in sufficient time to have been delivered on time.

Bid security in the amount of 5% of the Bid must accompany each Bid in accordance with the Instructions to Bidders.

The successful Bidder will be required to furnish a performance bond and a payment bond, each in an amount equal to 100% of the contract price.

Bidders on this work will be required to comply with the requirements of New York State Environmental Facilities Corporation (EFC) Water Infrastructure Improvement Act (WIIA) as they are funding the project (EFC NYS WIIA Grant Program Project No. 18606) as defined in the Bidding and Contract Documents. Minority and Women-Owned Business Enterprise and Service Disabled Veteran Owned Business Enterprise participation on this project is required as identified by EFC and included in the Bidding and Contract Documents.

Bidders on this work shall pay prevailing wages per the New York State Department of Labor: PRC #2019002351.
